Candelas Pool Guidelines

- Use of the pools at any of the Candelas Facilities is at the community members' own risk. There
 are no lifeguards on duty. Staff of Cimarron Metropolitan District and Vauxmont Metropolitan
 District (the "Districts' Staff"), including but not limited to pool monitors, are not responsible for
 the performance of any lifeguard duties. Adults are solely responsible for the supervision of
 children in their care at the Candelas Facilities.
- 2. Proper swim attire is required at all times while in the pool. Plastic pants or swim diapers are required for infants and toddlers. No street clothes, cutoff shorts, or athletic apparel is allowed in the pool.
- 3. Community members may only access the pool through the Candelas Facilities' main entrance only. Exit from the pool must be made through the pool gates. Pool gates are for exit only and will remain closed at all times. Community members are not to prop open the gates or let guests onto the pool deck through the gates.
- 4. Community members must practice physical distancing by standing at least six feet away from other groups of people not traveling with them while standing in lines and moving around the Candelas Facilities, including while in the pool.
- Each community member must review and sign the Candelas Facilities Waiver prior to entry. If a community member refuses to sign the Candelas Facilities Waiver, the community member will not be allowed to use the Candelas Facilities, including the pool.
- 6. While at the pool (both on deck and in the water), every community member must wear a wristband at all times. If a community member is found to be missing a wristband while at the pool, the community member will be asked to put their wristband on or leave the pool area immediately. Community members may stop by the Welcome Center to get everything they need for pool season. To do so, community members must bring proof of residency in order to receive their pool wristbands (driver's license, closing documents, etc.). To obtain a wristband, community members must sign the Candelas Facility User Guidelines, including these Pool Guidelines and Candelas Facilities Waiver. Should community members need replacement wristbands, they will be charged \$30.00.
- 7. Children under the age of 14 must be accompanied by an adult at all times. Children between the ages of 14 and 17 may be unsupervised by an adult at the pool only if a Candelas Facilities Waiver has been signed by a parent or legal guardian. Children between the ages of 14 and 17 who may be unsupervised by an adult at the pool because they have a Candelas Facilities Waiver on file are not allowed to supervise other children under the age of 18.

- 8. Large flotation devices are not allowed in the pool. On-body flotation apparel (such as vests or water wings), baby rings, pool noodles, and small kickboards may be used by community members, but will not be provided by the Candelas Facilities. Nerf-type balls and inflatable plastic beach balls are also allowed. The Districts' Staff retains the discretion to prohibit any pool toys that are disruptive to other community members.
- 9. The pool furniture will be available on a first come-first served basis. Pool furniture must stay in the spot that it is placed. Community members will not be able to bring their own pool furniture.
- 10. Community members under the age of 18 that are dependent upon a flotation device shall only be permitted in the pool when accompanied and directly supervised by an adult over the age of 18.
- 11. No pets are allowed in the pool or on the pool deck excluding service animals permitted by applicable state law.
- 12. No alcohol, drugs, smoking or weapons of any kind are allowed.
- 13. No glass containers are allowed outdoors. This includes the pool, pool deck and outdoor patio at the Candelas Facilities.
- 14. No running, diving or rough play is allowed. Community members are prohibited from playing on swim lane dividers. No bicycles, skateboards, scooters, or recreational devices with wheels are allowed in the pool, pool deck and outdoor patio at the Candelas Facilities.
- 15. Community members shall keep conversations and any audio devices at a level so as not to disturb other community members.
- 16. Community members shall dispose of trash in proper receptacles and areas returned to the state in which they were found upon the community members' departure.
- 17. Cimarron Metropolitan District and Vauxmont Metropolitan District (the "**Districts**") are not responsible for any lost or stolen items.
- 18. The pool and pool deck will be closed when lightning or other inclement weather is present.
- 19. Disregarding any rules, regulations, policies or procedures will result in the community member's removal from the pool and premises. Suspension or revocation of privileges may result from any disregard at the Districts' Staff sole discretion.
- 20. All community members agree to comply with posted regulations, including those contained in the Candelas Facilities Waiver.

21. The Districts reserve the right to amend or supplement these Pool Guidelines at their sole

discretion.
